

THEY ARE INVOLVED IN THE PROCESS THE WHOLE TIME. TO DATE, WE HAVE SERVED 37 ARTISTS, OVER 1,500 HOURS, AND OVER 160 SONGS RECORDED ACROSS 13 STATES.

THE MONTHLY DRIP HAD 11 NEW PRESENTATIONS AND THE PROGRAM ADVISORY GROUP MEETINGS HAD 10 MEETINGS.
